



**INTENT TO TRADE EUROPEAN EXCHANGES OTHER THAN LME**

R.J. O'Brien & Associates, LLC ("RJO") maintains relationships with multiple clearing houses in the European Union ("EU"). In order to allow for customers to access and trade on these exchanges, RJO must ensure that it and its customers are complying with all current and future regulatory & exchange requirements, including those requirements applicable in the EU that impact RJO and its customers.

Regulation (EU) No 600/2014 of May 14, 2014 ("MiFIR") is effective on January 3, 2018. Amongst the requirements imposed upon firms like RJO will be the requirement to comply with new transaction reporting requirements.

As of January 3, 2018, RJO will only be able to facilitate transactions with counterparties which have provided the MiFID information requested below. Please note that the information requested differs by account type. Account types associated with natural persons will require Country of Nationality AND Date of Birth or Passport Number, while account types associated with a legal entity will require a Legal Entity Identifier.

RJO requires for LME a separate disclosure form that must be signed by the end client. This form does not require a client signature, but must be completed if your client intends to trade on other European exchanges.
